## **Party Area Information**

- 1) The Time span is two hours as follows:
  - a) 11am-1pm; 1:30pm-3:30 pm; 4-6pm
- 2) Etsch Farms provides a **non-transferrable** wristband for your guests.
  - a) Everyone at your party gets one.
  - b) You are charged for everyone ages 3 and up.
  - c) Children ages 0-2 years are not charged for admission.

  - c) Apple Cider slushie - \$2.00 per serving.
- 7) **No alcohol** or smoking allowed. If you do not abide by this, you will be escorted off the premises and your party will not take place.
- 8) There are no rain dates or refunds.
- 9) Cash or credit cards are accepted for payment, with a 3% convenience fee for credit/debit card.
